NCOIL PROPERTY & CASUALTY COMMITTEE PASSES ASBESTOS CLAIM TRANSPARENCY MODEL LAW DURING INTERIM COMMITTEE CALL

Furthering the commitment NCOIL made to hold interim committee calls on a more frequent basis, the NCOIL Property & Casualty Committee met on Monday, June 5th and considered the Asbestos Bankruptcy Trust Claims Transparency Model Act sponsored by Sen. Jerry Klein (ND) and Sen. Bob Hackett (OH). The measure was carried without dissent.

"The language in this model is a common-sense approach" said Sen. Jerry Klein (ND).

"Similar legislation passed in my state and has provided greater transparency." "Similar legislation has passed in a dozen states" said Sen. Bob Hackett (OH).

"This is a smart way to reduce fraud and increase transparency."

NCOIL PLEASED ALI POSTPONED ADOPTION OF RESTATEMENT

In last month's newsletter, NCOIL raised serious constitutional concerns about the American Law Institutes 'Restatement' of liability law. Prior to the ALI meeting in May, the organization accounted it would be postponing consideration of the restatement.

"NCOIL legislators are pleased that the ALI heeded our advice" said Commissioner Tom Considine, NCOIL CEO. "We continue to call for an immediate dialogue with the ALI to ensure their restatements do not creep into the realm of legislative prerogative."

FORMER AGRICULTURE SECRETARY DAN GLICKMAN TO KEYNOTE NCOIL SUMMER MEETING

NCOIL is proud to announce that Dan Glickman, former Secretary of Agriculture and Congressman will serve as the keynote speaker at the 2017 NCOIL Summer Meeting in Chicago, IL. The luncheon will take place on July 14th at 12:45 p.m. at the InterContinental Magnificent Mile.

"I know Secretary Glickman will present an interesting keynote address for NCOIL legislators and participants" said Commissioner Tom Considine, NCOIL CEO. "He has diverse public policy experience that will inform us at the 2017 summer meeting luncheon."

Dan Glickman is Vice President of the Aspen Institute and Executive Director of The Aspen Institute Congressional Program. He also serves as a Senior Fellow at the Bipartisan Policy Center where he is co-chair of its Democracy Project. Prior to joining the Aspen Institute, he served as U.S. Secretary of Agriculture in the Clinton Administration.

He was appointed by former Secretary of Agriculture, Tom Vilsack as the Chair of the newly created Foundation for Food and Agriculture Research. He also represented the 4th Congressional district of Kansas for 18 years in the U.S. House of Representatives where he was very involved in federal farm policy on the House Agriculture Committee. He also served on the House Judiciary Committee and as chairman of the House Permanent Select Committee on Intelligence.

In addition, he is the former chairman of the Motion Picture Association of America, Inc. and former director of the Institute of Politics at Harvard University's John F. Kennedy School of Government. He has served as president of the Wichita, Kansas, School Board, was a partner in the law firm of Sargent, Klenda and Glickman, and worked as a trial attorney at the U.S. Securities and Exchange Commission.
