NCOIL HEALTH, LONG TERM CARE & HEALTH RETIREMENT COMMITTEE & AIR AMBULANCE TASK FORCE HOLDS INTERIM COMMITTEE CALL

The NCOIL Health, Long-Term Care & Health Retirement Committee and the Air Ambulance Task Force met during an interim Committee Call on Friday, October 13th to discuss the Outof-Network Balance Billing Model Act sponsored by NY Sen. James Seward and an Air Ambulance Insurance Claims Model sponsored by Asm. Will Barclay (NY).

"We heard a tremendous amount of comments that will ultimately produce a stronger model" said NY Sen. James Seward. "I appreciate the interested parties taking time to share their perspective."

The Health, Long-Term Care and Health Retirement Committee will continue to discuss the Out-of-Network Balance Billing Model Act when it meets at the 2017 NCOIL Annual Meeting in Phoenix on Saturday, November 18th.

The Air Ambulance Model was passed unanimously and was referred to the Health, Long-Term Care and Health Retirement Committee for consideration where it passed unanimously and was referred to the Executive Committee in Phoenix for consideration. Executive Committee Chairman & President Steve Riggs directed that the Health Committee make technical amendments at its meeting in Phoenix. educational programming and that is what we've done with this four-part series of programs."

Earlier this year, NCOIL and The Griffith Foundation hosted a live webinar and two live, onsite programs on both property-casualty coverages and life and health coverages at the NCOIL Summer Meeting in Chicago.

"By partnering with The Institutes Griffith Insurance Education Foundation, NCOIL is able to help educate legislators so they can advance informed public policy that ensures solvency and strong consumer protections" said Commissioner Tom Considine, NCOIL CEO. "More than ever, insurance and risk management play an important role in the financial fabric of our country, protecting many aspects of our personal lives, professional endeavors and national economy."

NCOIL anticipates a similar program for 2018 that will be announced after the new year.

FOR SECOND CONSECUTIVE YEAR, NCOIL STAFF PARTICIPATES IN "NO-SHAVE NOVEMBER"

NCOIL CEO Tom Considine announced that for the second consecutive year, the organization's staff will participate in No-Shave November 2017.

"Last year the NCOIL staff participated in No-Shave November 2016 and it was successful, albeit a little itchy. As I previously shared, as a cancer survivor myself, the fight against this disease has always been important to me" said Considine. "However, it became even more critical as my mother has battled lung cancer and bladder cancer over the past decade."

No-Shave November's mission is to raise funds for cancer research & treatment, and to educate the population about preventive measures. Starting with the surviving children of one father who died of cancer in November 2007, the movement has since spread around the globe. Participants put down their razors each year to join the fight against cancer. NCOIL Support Services has made contributions to the Melanoma Research Foundation, the Prostate Cancer Foundation and the Testicular Cancer Society in support of the men's health cause, Considine noted.

"I am pleased we are again participating in No-Shave November", said Executive Director Paul Penna. "It is an important to raise funds for cancer research, even if we are a little scruffy at the NCOIL Annual Meeting starting November 16th, but our legislators understand that it's for a good cause."

"Some people didn't recognize me at our Spring Meeting because the first time we had ever met was during mid-November last year, and in March I was clean shaven," stated Will Melofchik, NCOIL Legislative Director. "One person asked me if Will was at the meeting, but it's for a really good cause."

The No-Shave November campaign has successfully raised over millions to combat this disease. Every dollar raised brings us one step closer in our efforts to fund cancer research and education, help prevent the disease, and aid those fighting the battle.
