NCOIL CREATES CYBER-SECURITY TASK

At the direction of Sen. Travis Holdman, NCOIL President has created a Cyber Security Task Force. Rep. Steven Riggs, NCOIL Vice President will chair the task force that will examine the necessity for a single industry cyber bill. "Insurance legislators need to understand the impacts of a cyber bill aimed at one industry" said Rep. Riggs (KY). "We need to determine the necessity for it. The vast majority of legislators that serve on relevant insurance committees also regulate other industries."

The Task Force held a planning call on September 13, 2016. They will meet again in Las Vegas on Thursday, November 17th during the Financial Services & Investment Products Committee. At the Portland Summer meeting, the non-health general session was the first introduction to the NCOIL Innovation Series. At the Las Vegas meeting, a third general session has been added. Andrew Mais and Bernard Tubiana of Deloitte Consulting will discuss "Big Data and It's Impact on Underwriting in Life and Health Insurance. "This is a subject that will eventually impact all sectors of the insurance industry" said Commissioner Tom Considine, NCOIL CEO. "It should be an enlightening discussion and we expect interesting insight from the presenters and participants."
