of registered voters support the federal government requiring hospitals to post their prices so everyone can see the fees.



of voters believe the Biden Administration should hold hospitals and health insurance companies accountable.

Standard charges must be posted two ways:



Machine Readable File

Single machine-readable digital file containing the following standard charges for all items and services provided by the hospital: gross charges, discounted cash prices, payer-specific negotiated charges, and deidentified minimum and maximum negotiated charges.

Consumer-friendly Display of Shoppable Services

Display of at least 300 "shoppable services" (or as many as the hospital provides if less than 300) that a health care consumer can schedule in advance. Must contain plain language descriptions of the services and group them with ancillary services, and provide the <u>discounted cash prices</u>, <u>payer-specific negotiated charges</u>, and de-identified minimum and maximum negotiated charges.

Empowering patients with the necessary information to make informed health care decisions.

The AHA is supporting this activity by highlighting tools that aid patients and align with the new federal price transparency policy. The first requirement of the policy includes a provision around "shoppable services" that can be met through the use of a patient cost estimator tool, an approach that has been widely adopted. Hospitals and health systems have been able to increase adoption of these tools due largely to growth in the availability of technological resources at multiple price points and with increased functionality. In particular, this "next generation" of price transparency tools are easier for hospitals to implement and for consumers to navigate.



Unexpected Surprises

- Estimator only addresses "shoppable services"
- Technical Only
- Facility Fees (CPT Q3014 with POS 22)
- Unexpected Add-On

Symptoms of Opacity

Difficulty Affording Healthcare

- About half of U.S. adults say they have difficulty affording health care
- 4 in 10 U.S. adults have delayed or gone without medical care in the last year due to costs
- A substantial share are adults 65 or older especially services not covered (hearing & dental)

Difficulty Affording Medication

- About a quarter of adults say they or a family member have not filled Rx
- Skipping pills or cutting pills in half are being reported due to cost barriers
- Many of these have attempted to purchase medications outside of the U.S.

Medical Debt & Bankruptcy

- Over 60% of those that are bankrupt due to medical debt have insurance
- 44% of U.S. adults worry about affording their deductible before insurance kicks in
- During record inflation (2022), more adults are concerned about affording medical costs

Expected Solutions

- Price estimates in advance of any scheduled service for patients within 24 hours of request
- Estimate should be binding barring any documented complications
- Failure to provide estimates in advance of service will result in a forfeiture to collect any balance from the patient
- Forfeiture also means hospital may not aggressively collect, report to credit bureaus or litigate patients
