## From the President's Desk

*Rep. Deborah Ferguson, DDS (AR) – NCOIL President*

Welcome to my first quarterly newsletter column as NCOIL President.

When I joined the NCOIL Officer ranks last year, I certainly didn't anticipate being NCOIL President just a year later. But with the unfortunate departure of Kevin Cahill from the NY legislature, we had to adjust "on the fly" and I'm really looking forward to another productive year at NCOIL. It's a great honor to serve alongside such a talented team of fellow officers: Vice President Dr. Tom Oliverson, (Rep. TX), Treasurer Pamela Hunter (Asw. NY), Secretary Paul Utke (Sen. MN) and Immediate Past Presidents Matt Lehman (Rep. IN) and Travis Holdman (Sen. IN).

Yes, you read that last name correctly. Sen. Holdman is now back in the NCOIL Officer ranks due to Ken Cooley sadly losing his re-election soon after we departed our New Orleans meeting. Asm. Cooley deserves a tremendous amount of credit for his leadership last year as NCOIL President, and for the way he consistently represented the organization throughout the years. Thanks to Ken's leadership, NCOIL starts 2023 stronger than ever and ready for another great year.

As I begin my term as NCOIL President, I'd like to tell you more about myself and how I got involved in public service and in NCOIL. Prior to being elected to the Arkansas House of Representatives, I spent twenty five years working as a dentist and owned my own practice. I also became involved with various causes in my community such as serving as a Guardian Ad Litem for foster children, teaching elementary Sunday School, and working with organizations such as the American Heart Association and the Arkansas Arts Council among others. This involvement in my community along with my desire to and belief that I could help improve Arkansas is what ultimately drew me to run for elected office.

The timing of when I first ran for the legislature really was sparked by the passage of the Affordable Care Act (ACA). I knew that enactment of this federal law would mean state legislators had to roll up their collective sleeves as well.

During my time in the Legislature, I have served on the Insurance Committee for eight years and as Co-Chair of the Insurance Marketplace Sub-committee for eight years. I was recently appointed as Co-Chair of the Employee Benefits Division Insurance Sub-committee to implement Medicare Advantage for our retired teachers and state employees. I am also the Vice-Chair of the Public Health, Welfare, and Labor Committee.

## From the President's Desk (cont'd)

I attended my first NCOIL Meeting in San Francisco in 2014. I had already been very familiar with health insurance and healthcare related issues from my work as a dentist, but it was at NCOIL that I learned about the intricacies of all different lines of insurance. It was great to be able to discuss the issues we were dealing with in Arkansas with legislator colleagues from all around the country. From that point on, I was hooked!

I was impressed with each subsequent NCOIL Meeting I attended because it provided an opportunity to learn about a wide array of issues facing the insurance marketplace and how other states are finding solutions to improve the quality of insurance for their citizens. Each NCOIL conference has proven to be both productive and efficient and they provide an excellent opportunity to hear various perspectives on timely issues. This focus on policy is why I encourage all legislators serving on their state's insurance committee to get involved in this national forum.

During my tenure as NCOIL President, I will focus on the continued advancement of the organization from both a substantive and legislative membership perspective. NCOIL is at its strongest when there is robust participation from legislators all across the country that come together to share their thoughts and views on insurance public policy. Throughout my time at NCOIL, I've found that its bipartisan makeup really provides more credibility to the organization as a whole. As a state legislator, when you see an NCOIL model law come before you in your legislature, you know that both sides were heard throughout its development and that the NCOIL legislators that voted on the Model heard all perspectives from a wide array of subject matter experts. NCOIL must continue meeting its mission of being a bipartisan organization and I look forward to working to ensure that happens.

Additionally, beyond its bipartisanship, I plan to continue NCOIL's commitment to diversity of talent, thought, and background. When I first came, Assemblywoman Maggie Carlton and I were the only regular women attendees; we could have had women's caucus meetings in a phone booth. I plan to establish an official Women's Caucus to bring even more women to the table. We will also work to further increase the diversity across the board in our own membership to continue NCOIL's path of looking more like America.

The issues facing the insurance marketplace this year will prove to be exciting and complex and NCOIL is committed to remaining on the cutting edge in terms of topics to discuss during its national meetings. Some topics already set for our Spring meeting include: consideration of Rep. Lehman's Insurance Underwriting Transparency Model Act; continued development of Asw. Hunter's Biomarker Testing Insurance Coverage Model Act; the potential impact of *Braidwood Management v. Becerra* on no-cost preventive services; and of course, discussion on how environmental, social and governance (ESG) developments can impact the insurance marketplace.

I am particularly looking forward to having NCOIL actively engage on ESG developments to navigate the potential minefield of the issue. Absent our involvement, this is the type of issue that could all but beg for federal regulation of insurance and I'm proud that NCOIL is taking a leading role in the debate on this topic in 2023.

Like my predecessors, I am committed to ensuring that NCOIL continues to educate public policymakers and interested parties and produce sound public policy in the form of model laws for states to consider and adjust accordingly to meet their needs.

I look forward to your participation and to seeing you at our Spring Meeting in San Diego. Please do not hesitate to share your ideas or thoughts with me in March and throughout the year.

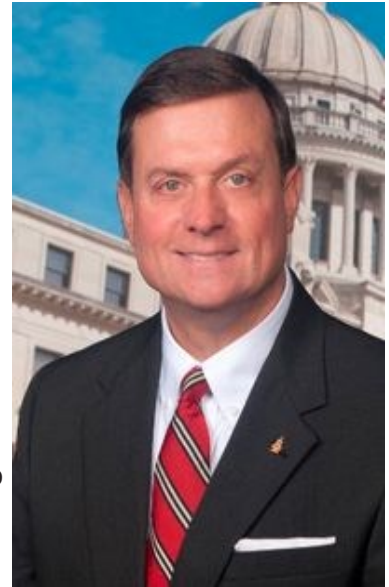
