## High Drug Prices Affect Older Adults

### Utilization of Rx is high


#### Among adults 65+

- 42% take 5 or more drugs
- 18% take 10 or more drugs

#### Among adults 50-64

- Over 70% take one or more drugs
- Medicaid enrollees: 3.3 prescriptions/month
- ESI: Utilization increased 10% over 5 years



## High levels of concern around affordability of prescription drugs

Registered voters age 50 to 64 are more likely than those age 65 and older to express concern about being able to afford prescriptions (63% very or somewhat concerned vs. 49%).


## **Older Adults Want Transparency**

67% of adults 50+ say prescription drug prices are unreasonable.



88% of adults 50+ support requiring drug companies to publicly disclose how prices are set.

## **Annual Increases in Drug Prices**


#### All Drugs

- In 2020, the average annual retail price per drug: \$26,363.
- Cumulatively, the average retail drug price increased 279.5% over 15 years.

#### **Specialty Drugs**


- In 2020, the average annual retail cost per specialty drug: \$84,000.
- In 2020, 41% of specialty drugs widely used by older adults increased 8-21%.
- Cumulatively, prices for a set of chronic-use specialty drugs on the market since 2006 increased an average of 234.2% over 15 years.
