WHEREAS, Neil Breslin served with distinction for nearly three decades in the New York State Senate after being elected in 1997; and

WHEREAS, Neil has been a longtime active NCOIL fixture, having served as Chair of the State-Federal Relations Committee, Special Committee on Race in Insurance Underwriting, and in each of the NCOIL Officer positions, culminating with his successful tenure as NCOIL President in 2014 and 2015; and
