From the President's Desk

Asw. Pamela J. Hunter (NY) – NCOIL President

Welcome to my first quarterly newsletter column as NCOIL President.

I hope everyone has had a great start to 2025 and is looking forward to what is sure to be another productive year at NCOIL. I'd like to begin with a big thank you to my predecessor, Texas Representative Tom Oliverson for his leadership last year. Representative Oliverson did an excellent job at the helm, and he deserves a lot of credit for the strong position the organization is in now.

We made a lot progress in 2024, both substantively and attendance wise, with seven new Model Laws adopted on important issues including medical loss ratios for dental (DLR) health care services plans, public adjuster professional standards reform, value-based purchasing agreements, regulation of earned wage access (EWA) providers, transparency in third party litigation financing, expanding access to mental health wellness exams, and incentivizing homeowners to strengthen their homes against natural disasters. We also saw participation from 147 legislators from 41 states which is a very positive sign for NCOIL's growing legislative membership.

As I kickoff my term as NCOIL President, I'd like to share more about myself and how I got involved in public service and in NCOIL, as well as some of the things we have planned for the year ahead.

Prior to representing the 128th District in the New York State Assembly, where I have served since 2016, I was a member of the Syracuse Common Council for 3 years where I Chaired the Public Safety Committee. I also served in the Army, where I received a commendation medal and two achievement medals. Currently, I was just recently appointed Speaker Pro Tempore of the New York Assembly and have served previously as the Chair of both the Committee on Banks and the Subcommittee on Women Veterans.

Throughout my time in Albany, I have always served on the Insurance Committee and prioritized it among the Committees I requested to join. Insurance really does touch every aspect of our lives and I wanted to gain the knowledge and experience around these issues to best help my constituents navigate the challenges they face. A large part of my interest in insurance stems from my former colleague Assemblyman Kevin Cahill, then Chair of the Assembly Insurance Committee and longtime NCOIL participant, who recommended that I start joining him at NCOIL meetings. Each Meeting I attended provided a fantastic opportunity to learn about emerging insurance issues and

how different states are dealing with them to promote the best marketplace possible for their constituents.

As my involvement and interest in NCOIL grew, I knew I wanted to do all I could to positively impact the organization and in 2019 I was delighted to have been asked to join the policy committee leadership. I served as Chair of the Health Insurance & Long Term Care Issues Committee for four years before ultimately deciding to run for an NCOIL Officer position at our 2022 Annual Meeting where I was elected Treasurer. I then served as Vice President before assuming the NCOIL Presidency at the conclusion of our recent Annual Meeting in San Antonio.

It's a privilege to be serving alongside a very accomplished team of fellow Officers this year: Vice President Paul Utke (Sen. MN), Treasurer Edmond Jordan (Rep. LA), Secretary Jim Dunnigan (Rep. UT) and Rep. Oliverson as Immediate Past President. I look forward to working with this Officer group as we continue to advance the organization in the year ahead and beyond.

NCOIL is excelling as an organization now, but there is always room for improvement and we never want to rest on our laurels. As part of my term as NCOIL President, the organization will be conducting a Strengths, Weaknesses, Opportunities, and Threats (SWOT) exercise. We conducted the same exercise in 2016, and it proved to be very valuable in guiding NCOIL through what were then difficult times for the organization. During our upcoming Spring Meeting in April, we'll have time set aside on the agenda for all attendees to offer their thoughts and feedback. We'll be sending out more information on this in February.

Additionally, in response to requests following the San Antonio Meeting, we are in the process of putting together a handbook that memorializes certain practices that the organization has been following the past several years, but aren't set forth in the bylaws, so that everyone that comes to NCOIL is fully aware of its processes and knows what to expect. If you're reading this, you're likely familiar with how many regulatory agencies often operate under "desk drawer rules" in addition to the agency's statutorily designated authority. What we envision with this handbook is somewhat of a compilation of NCOIL's "desk drawer rules" so that everything is public and everyone knows the playbook. The best example of this is the three Meeting Model Law development process of introduction in the Spring, further discussion in the Summer, and voting in the Fall. Thanks to everyone who has already reached out about this expressing support for the idea.

From a substantive perspective, one of the issues I'm looking forward to seeing NCOIL be engaged with this year is artificial intelligence (AI). From a high-level standpoint, I think it's incredibly valuable for the organization to have experts come to our Meetings to educate everyone on what the latest trends and developments are, particularly with something as topical as AI. More specifically, [I've introduced a bill in New York this year](#) that would require insurers to provide notice when AI algorithms are used in evaluating the medical necessity and appropriateness of care, also known as utilization reviews. Other states have introduced, and in some instances passed into law, similar bills so I think it's important for NCOIL to look at this legislative trend and consider developing Model policy for states to consider adopting.

Further, while the Meeting agendas for 2025 are sure to be busy with several topics already planned for discussion, one of the strengths of NCOIL is its flexibility in responding to new issues that we may have not anticipated at the onset of the year. A prime example of that is the impact of the devastating wildfires that continue to burn in California. To that end, we'll be having an interim meeting of the Property & Casualty Insurance Committee on February 14th where we will begin to examine the aftermath and insurance implications of these tragic events. It is beyond words to describe the loss and devastation that those effected are experiencing but it's important that NCOIL is at the forefront of educating public policy makers on how insurance will play a major role in recovery.

As we continue to advance the organization and deal with the critical public policy issues before us, meaningful progress can only be achieved with a robust legislative membership. Having a range of perspectives from different states, different backgrounds, and different expertise is essential in shaping public policy that is representative of all corners of the country. This is why I encourage all legislators that sit on their states' committees with jurisdiction over
