Our Spring Meeting in San Diego was a huge success from both a substance and attendance perspective. I am happy to report that we had the highest legislator attendance at a Spring Meeting ever which is a great indicator of NCOIL's continued growth. Having more legislators from around the country at the table contributes to more informed policy discussions, better model laws, and ultimately a stronger NCOIL.

I was particularly pleased to see a near perfect split of Democrats and Republicans at the Meeting which really highlights NCOIL's ongoing commitment to bipartisanship. It's one thing to just say the organization is bipartisan, and another thing entirely to actually back that up with numbers. While it is sometimes hard to tell which political party an NCOIL legislator is from since the discussions we have are often so collaborative, having a balance of viewpoints from both sides of the aisle really enhances our conversations and emphasizes the credibility of our model laws as they are considered in legislatures across the country.

In addition to the bipartisan nature of the Meeting, the number of first time legislator attendees (19) is another positive sign for NCOIL's future. Bringing more legislators into NCOIL's membership is mutually beneficial as it provides new perspectives in our discussions and gives legislators useful information to take back to their states as they navigate the various issues impacting insurance public policy. We certainly hope to see many of those legislators at our Summer Meeting in Minneapolis and beyond!

I also want to thank the industry members that sponsored dinners specifically for legislators attending their first NCOIL meeting. This was our first time trying this and based upon what I heard, it was a success and we'll be doing it again in Minneapolis. I think these dinners are a great idea because, despite our best efforts to be welcoming, too often it's a "sink or swim" approach for legislators attending their first NCOIL meeting. It really helps to have time carved out to meet people and learn about their background.

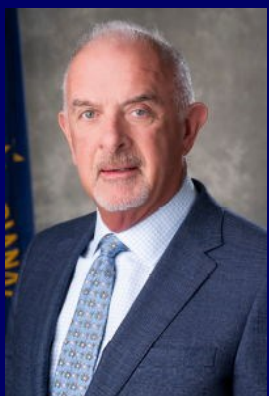

NCOIL Highlights April as Financial Literacy Month (cont'd)

NCOIL CEO Commissioner Tom Considine stated, "Whether it's an unexpected car accident, medical bill, or natural disaster, having life's unanticipated losses covered will keep you on track to meet your financial goals. Beyond the insurance aspect, having a well-rounded financial plan is essential to a person's short and long term prosperity."

"When I was the Banking & Insurance Commissioner of New Jersey, I frequently visited high schools across the state to stress the importance of financial literacy. I would always tell stories of how we weren't as focused on financial literacy when I was in school and I would often make the mistake of buying an \$8 pizza on my credit card and it would end up costing me \$50 by the time I paid it off. Avoiding those types of mistakes and learning about basic financial principles is very important to ensure financial security" Considine concluded.

The purpose of the meeting is for the Committee to continue discussion on the NCOIL Biomarker Testing Insurance Coverage Model Act, sponsored by Asw. Pam Hunter (NY), NCOIL Treasurer. As communicated by Chair Westfall and Asw. Hunter during the Committee's last meeting in March, the Committee plans to vote on the Model during the NCOIL Summer Meeting in July.
